Subject: Announcement of Mandatory Code of Conduct and Strict Disciplinary Rules for the Smooth Conduct of the Upcoming Pulwama "Jazba-E-Pulwama" Grand Marathon on 31 July 2026.

PULWAMA, 28 July 2026 A special organizational meeting was held today under the chairmanship of the Director of the Save India Youth Foundation SIYF.

The primary objective of this meeting was to review the preparations for the historic **"Jazba-E-Pulwama" Grand Marathon** scheduled for **31 July 2026**, and to finalize necessary security and compliance standards to maintain sportsmanship and public order. The marathon will trace a route from Samboora Pampore Cricket Ground to New Bus Stand Drusoo Pulwama.

The Save India Youth Foundation SIYF aims to promote sportsmanship, community solidarity, and health awareness among the youth through this athletic event.

The organization membership has made it unequivocally clear that any form of anarchy, indiscipline, or politically motivated disruption will absolutely not be tolerated. To ensure the event remains completely transparent and fair, strict rules are being enforced.

Mandatory Warning & Disciplinary Conditions:

Rule Violations and Incorrect Protocol: If any participant deviates from the designated route, utilizes unauthorized transport, or relies on improper means such as the covert assistance of police or private vehicles, or is found violating the established event protocols, they will be immediately disqualified.

Vandalism and Property Damage: Any elements found destroying, damaging, or vandalizing venue property at Samboora Pampore Cricket Ground or along the route including tents, chairs, barricades, or any public/private infrastructure will be removed from the race instantly.

Withholding of Winning Prizes:

Any winner or participant found violating the rules or participating in vandalism will not be awarded any winning prize, medal, or certificate.

Legal Action and Financial Recovery : One hundred percent of the financial losses resulting from any vandalism will be recovered directly from the responsible individuals or groups, and criminal cases will be registered against them with law enforcement agencies.

To ensure the successful execution of the marathon, dedicated teams of organization workers and volunteers will be deployed across the entire route to closely monitor all activities. Furthermore, the entire event will be documented using **high-definition (HD) cameras** and **videography** to ensure conclusive digital evidence is available in the event of any misconduct or protocol breach.

The Director has appealed to all participants to compete in the true spirit of the sport and contribute to raising the pride of Pulwama. If any anti-social elements attempt to disrupt the peace or spread malicious rumors, the organization will ensure the strictest possible action is taken against them with the help of the administration and law enforcement agencies.
